# WTS Begins 169<sup>th</sup> Academic Year convocation reflection from rev. dr. jan schnell



Convocations, a long-standing tradition at Wartburg Seminary, are community conversations about topics that matter. They focus on current, often-challenging topics that deserve face-to-face dialogue. Convocations strive to host discussion in ways that bring us together as community, invite open-ended questions, and welcome everyone's voice. Convocations are neither lectures nor simply presentations. They are face-to-face conversations, inspired by Jesus' teachings that strive for mutual understanding, solidarity, and wholeness in communities today. The following is a spoken word reflection from Rev. Dr. Jan Schnell, Assistant Professor of Liturgics, that she shared with more than 140 students, faculty, and staff at this year's fall Convocation, Wartburg's Identity as Community in Christ:

You've heard it already now hear it apace Jesus is the center, who has been, is, and will be the dayspring of grace

For the church, a healthier setting has been wilderness, not empire We refuse to dampen with discouragement in this world's partisan mire But recognize that living baptized, wet kindles the Spirit's fire

It'll be the strangeness of the gospel of Jesus Christ Not the structures of an ivory tower raised to heights

That will characterize the future of WTS Where learning leads to mission and mission informs

Yes

Everything. Because God's movement in the world, with the Spirit loosed and Jesus found Makes you free as free, and in that freedom love-bound

The future's more colorful in so many ways People who are Black, Brown, and Rainbow leading God's praise

Wartburg will lead in telling the truth Acknowledge land and labor, Löhe's impact on Ojibwe neighbor

Honesty will not threaten existence For it is the way "Open Questions" and "12 Practices" find their persistence

We all know you can't make Beloved Community alone So we sit down with those around, even on the days it feels more like groan or postpone, in order for God to hone

Us in the image of Jesus' inbreaking Where many-a-table become Eucharistic partaking

Some of us come on our feet and sit in this seat Others are just as present online and in asynch time

Whatever your pathway, modality, program, or song We call each other to our next better step because each of us belong

# Report on the 5th Conference of the International Loehe Society



From July 24 - July 27, Wartburg Seminary hosted the 5th Conference of the International Loehe Society under the theme "Christian Identity in Crisis: The Legacy of Wilhelm Loehe as Inspiration for the Church Today." Over 40 participants gathered on campus and a handful of others joined the presentation sessions by Zoom. Participants came from Germany, Switzerland, Australia, Canada, and the US, including a number of Wartburg Seminary faculty, alumni, and friends.

The idea for such a society resulted from conversations between professors Craig Nessan and Thomas Schattauer about bringing together people with interest to explore the work of the Franconian Lutheran pastor Wilhelm Loehe as a living legacy for the church today. The organizing conference was held at Wartburg Seminary July 2005, with subsequent meetings every three years alternating between Germany and the US. The days of the conference were full with presentations (twelve in all!), worship, and good fellowship over breaks and meal times. In the words of Prof. Nessan, "we experienced the spirit of life together in Christian community. The conference theme helped us retrieve and claim the witness of our founder, Wilhelm Loehe, for the challenges of mission in our time." There was also a trolley tour of historic Dubuque and an excursion to Wartburg College, Waverly, Iowa, and St. Sebald Lutheran Church, which like the seminary trace their history to Loehe's Sendlinge (sent ones). At St. Sebald, the group visited the site in the countryside where the seminary was located from 1857-1874.

The conference featured significant contributions from Wartburg Seminary faculty to a constructive and critical reflection on Loehe and his legacy: professors Nessan on the future church, Yip on a borderless Christianity, Schattauer on liturgical imagination, and Schnell on the encounter with Native Americans. In addition, volunteer seminary archivist Jean Peterson reported on the collection of data on Loehe's Sendlinge. "All the presentations were excellent and showed a great range of scholarship and perspectives connected to Pastor Loehe," commented Prof. Martin Lorhmann, who himself preached at the opening worship. President Kristin Largen expressed gratitude for the work of the International Loehe Society, "critically exploring the legacy of Wilhelm Loehe: challenging assumptions, bringing new insights and helping us learn more about who we have been, in service of who we are becoming."

# Jerry and Annette Johns Establish Scholarship for Diversity in Ministry


# "WE BELIEVE WE ARE ALL GOD'S CHILDREN."

Education holds a special place in the lives of Jerry and Annette Johns. Annette spent her career at the elementary level before teaching philosophy at a community college. Jerry spent five years as an elementary and reading teacher before moving on to Northern Illinois University, where he spent 30 years as a professor and director of a literacy clinic.

As educators, they each worked with students of varying backgrounds, experiences, and perspectives. While they say those experiences don't necessarily make up the bulk of their careers, it factored into the decision of how to best share their financial resources.

"As we've matured, we've become more sensitive to the diversity we have in our country and thought it would be good for us to devote some of our energies there," stated Jerry. Annette added, "I think, especially lately, people of color experience too much prejudice and difficulty in their careers and personal lives. We recognize our own privilege and want to do what we can to make it simpler, easier, and more equitable for others."

During the COVID lockdown in 2020, Jerry connected with Wartburg's Lead Development Officer, Dan Potaznick. In talking with Dan, the Johns learned more about what was being done to support historically underrepresented groups, like the launch of a new



program, Centro Teológico Luterano Multicultural (CTLM). They also discussed what was anticipated, including Caminemos Juntos/ Journey Together. To further plan for a more inclusive future, the Johns Scholarship for Diversity in Ministry was established. "I think seeing more non-white people in positions of power in the church is a good thing. And if our gifts help in that regard, that's great. We believe we are all God's children; there are no exceptions," stated Annette. Jerry went on to explain, "I think when people can contribute, they ought to. We know that our gift might not make a giant difference, but even a small impact can be meaningful, especially over time." He continued, "It's like planting a tree that starts small but grows into one that sustains all kinds of life and provides welcome shade. We hope that starting this scholarship is the seed that gives people from marginalized groups a better chance to become church leaders through Wartburg."

# J-Term Experience Inspires Gift flexible thinking and open mindedness important for diversity

A J-Term experience to Pine Ridge, South Dakota had a profound impact on the way Linda Wiles Davis, (M.A. '03), thought about ministry. Shortly after their marriage, Linda and her husband Lawrence joined a Presbyterian church in New York City. It was a small congregation, so they formed a joint parish with the Norwegian Free LutheranChurch across the street. In 1975, when they moved to Manhattan, Kansas, they joined Peace Lutheran Church. Later they transferred to First Lutheran Church in Manhattan.

A busy woman, tasked with raising three children and balancing a career in biology, Linda recalls having an urge to do more with the Church but not really knowing where to start. An avid reader with a great interest in theology, Linda had always wanted to learn Greek. So, when Winston Persaud, Professor of Systematic Theology and The Kent S. Knutson & UELC Professor in Theology & Mission at Wartburg



visited the Central State Synod and visited her church, it seemed only natural to ask him for a reading list. And while the reading list was provided, it was the gentle prompting from Persaud for Davis to check out Wartburg Theological Seminary that turned out to be life changing.

After some thought, Davis enrolled in Wartburg's Summer Greek class. A brief interruption due to a health issue didn't deter Davis, and it was a short couple of years later that she returned to Wartburg to enroll as a diaconal candidate in the MA Program, "So I got to do my Greek after all," stated Davis. "I really appreciated the faculty all around, especially May Persaud, and Winston Persaud of course, and someone who really influenced me was Nate Frambach, who taught Congregational Leadership. Nate made sure I was always completely included even though I wasn't intending to become a pastor."

Throughout her studies, Davis clearly recalls learning how ministries operate and the many kinds of leadership required to be successful in various kinds of congregations with different types of populations; "I learned that ministry is not like pie, where you cut the pie and there are only 6 or 8 pieces and when you run out, that's it – instead ministry is like bamboo or crab grass... you cut it down and it multiplies. So, once you engage in one kind of ministry, more and more ministries pop up. There are always more opportunities." *Continued on page 30* 

# WTS Alternative Internship Sites

# NOKOMIS HEIGHTS, MINNEAPOLIS AREA SYNOD

Wartburg is committed to identifying and nurturing internship sites ready to receive students from diverse communities. Through conversation with Wartburg alumnus Pastor Kris Capel, Rev. Stacey Nalean-Carlson, Wartburg's Director for Contextual Education, learned that Nokomis Heights Lutheran Church, in response to its changing south Minneapolis neighborhood, had launched a Bilingual Learning Center and had recently begun introducing Spanish into its weekly worship services. "In that conversation with Pastor Kris, the Holy Spirit was stirring. I immediately thought of a student, Yesenia Morales Bahena, whose internship site we were still seeking," stated Nalean-Carlson. Yesenia immigrated to the United States from Mexico; her native language is Spanish, and her hope was that her internship would give her experience leading and learning in a bilingual, multicultural church. Once Pastor Kris and Yesenia met for some initial conversation, it was clear that this connection was indeed the work of the Holy Spirit. "I am delighted and exceedingly grateful that the generosity of those who direct gifts to Wartburg for the nurturing of the internship program enabled this internship placement to move forward in partnership with the Nokomis Heights congregation and the Minneapolis Area Synod," stated Nalean-Carlson. Of the experience, Bahena stated, "I'm grateful that I have been welcomed as I am, even though that means that there might be moments where people need to sit with their uncomfortableness when we're getting to know each other, I'm grateful that everyone has an open heart to welcome me as I am and to just learn together not for us, but for the Church."





## THE DWELLING: WINSTON-SALEM, NORTH CAROLINA

Wartburg is deeply committed to forming evangelical leaders capable of developing and revitalizing congregations and organizations serving the gospel in the world. To this end, Wartburg has set a goal to identify and nurture contextual education sites that are deeply connected to innovation, mission development, and church revitalization. Much to the surprise and great joy of Director for Contextual Education, Rev. Stacey Nalean-Carlson, an email arrived in early February from Pastor Danielle DeNise, Director for Evangelical Mission in the North Carolina Synod. Pastor DeNise shared her synod's dream to consider The Dwelling a training site for pastors to learn best practices and essentials for creating faith community centered in economic equity. The Dwelling, in Winston-Salem, North Carolina, is for those experiencing homelessness and is served by Pastor Emily Norris, a Wartburg alumnus. That initial email led to some exciting conversation to imagine how Wartburg might partner with The Dwelling and the North Carolina Synod to raise up leaders equipped for the essential work of mission development. "Once again, the Holy Spirit was on the move!" stated Nalean-Carlson. Out of this conversation emerged an internship placement for Michael Schulte, a Wartburg affiliated student, who had already been exploring a call to mission development with a focus on pursuing equity in education, housing, and employment. Of the assignment, Schulte says, "I'm really grateful to be able to see how the possibility of what a non-traditional church can look like within our denomination that we can be a church that moves outside of our normal four walls and serves people in the margins very intentionally." Nalean-Carlson added, "I am so eager to see how Michael's sense of call is shaped by his internship experience with The Dwelling. It is incredible to witness God at work through dreamers and donors. Again, the generosity of those who direct gifts to Wartburg for the nurturing of the internship program enabled this internship placement to move forward in partnership with The Dwelling and the North Carolina Synod. # **MEET THE DEVELOPMENT TEAM**

The Development Team's ministry is focused on helping people of faith experience the great joy that comes from partnering with the mission of Wartburg Seminary.

In 2 Corinthians 8, the Apostle Paul goes into detail about his visit to Macedonia. Describing their generosity and their concern for others, Paul writes that the Macedonians "voluntarily gave according to their means and even beyond their means, begging us earnestly for the favor of partnering in this ministry to the saints." This description also identifies the focus and mission of Wartburg's Department of Development. The Development Team's ministry is focused on helping people of faith experience the great joy that comes from partnering with the mission of Wartburg Seminary.

Paul Erbes, who is in his sixth year of guiding this vital ministry, recently highlighted some of the unique aspects of Wartburg development. "Wartburg is blessed by some of the highest supporter loyalty in the country. In fact, Wartburg consistently ranks in the top 10 for alumni support out of all 280 seminaries in North America."

Another factor that has contributed to the significant growth in financial support from donors over the past several years is trust. 

# A Note from the President

As [Philip and the Ethiopian eunuch] were going along the road, they came to some water; and the eunuch said, 'Look, here is water! What is to prevent me from being baptized?' He commanded the chariot to stop, and both of them, Philip and the eunuch, went down into the water, and Philip baptized him. When they came up out of the water, the Spirit of the Lord snatched Philip away; the eunuch saw him no more, and went on his way rejoicing. But Philip found himself at Azotus, and as he was passing through the region, he proclaimed the good news to all the towns until he came to Caesarea" Acts 8:36-40.

These past few years, many potential ordained leaders have been prevented from attending seminary for a variety of reasons: health concerns, family needs, costs, and travel restrictions.

God, however, creates opportunities where others see only obstacles, opening new doors and forging new roads for us to travel as we continue to seek the inspiration of the Holy Spirit. Here at Wartburg Theological Seminary, we rejoice that God has continued to be at work in and through you, such that we are able to overcome barriers and fulfill our mission to raise up new leaders for the church, for the sake of the gospel and the world. What is to prevent us? With your help and support, nothing!

There are many financial realities that hinder qualified and talented candidates for public ministry from attending seminary. Your gifts are helping us actively remove barriers of cost, providing more scholarships, and more support, paving the way for more candidates to graduate from Wartburg and serve waiting congregations and Christian communities.

#### What is to prevent me? Thanks to your generosity, not educational debt.

There are many exciting Christian ministries that desperately need a pastor or deacon to lead them into the future to which God is calling them, but sometimes it is all they can do to meet minimum salary guidelines for an ordained leader. The opportunity to complete her J-Term at Pine Ridge, South Dakota was one such instance. "Pine Ridge was a very different kind of ministry and setting, and while I was only there two weeks, it enhanced my vision of what ministry could look like." This was important to Davis who states, "In regard to the future of the ELCA, we need to have people who know how to carry on what has always been done, but even more so, we need people who can do something new, too. Because the way we've always done it isn't always going to cut it."

As Davis continued to reflect on her visit to Pine Ridge and the internship program at Wartburg, she began a discussion with Wartburg's Development team. Davis shared her vision with the team, noting, "I really think the future of the church depends on us being more open, and more flexible, and having pastors in particular who are able to go in somewhere and look at the opportunities and know how to work within a great variety of circumstances." After learning about Wartburg's alternative internship sites, located in Nokomis Heights, Minneapolis and Winston-Salem, North Carolina, Davis knew that she wanted to contribute to the efforts. "I really wanted to give to something that would carry into the future and the alternative internship sites seemed like something that needed a boost to get going, so it seemed like the right place for me to support financially."

Davis' hope is to see the alternative internship program grow and flourish; "Anything that requires flexible thinking, open mindfulness and creative thinking, is good for the future of the ELCA," stated Davis. She went on to say, "Pine Ridge was so educational for me; it changed my view of how ministry could be done and opened me up to consider all different kinds of opportunities. There is always new work to be done, and I am very pleased to support the alternative internship sites effort for Wartburg students."


